TBF of CT Board of Director's meeting minutes of August 19, 2010

Attendance: Bio Bass, Bass Hunters, Midstate, Southeast, Bass Finn-addicts, Valley B/M., Schagticoke.

Minutes: The minutes for the July meeting were approved as written.(motion by D. Gambardella; second by R. Suhie - motion passed).

Treasurer's Report: All dues have been reconciled with National TBF.

Youth Report: The Nationals were tough only 33 of 82 Junior Anglers caught fish the first day. The National Guard treated the Junior Anglers GREAT!! Next year the Junior Nationals will be held in Arkansas; it will cost more to send them than this year. We need to start planning now.

At the junior nationals there were fund raisers proposed. Dom Gambardella will be briefing the Youth Director and junior members. Dom also stated there may be tournament changes at the Junior Nationals. More info to follow.

Tournament Director: The regular trail is done and the two-day for the 2011 state team is on the horizon.

State Team: Two day pairings will be held Tuesday August 24<sup>th</sup> in Milford at 8pm. A mandatory 2010 State Team meeting will be held at 7pm - just before the pairings,

A motion was made by J. Sherman; second by J. Marks; to approve the reports. Motion passed.

#### **OLD BUSINESS:**

Lowrance is back as a National TBF sponsor. We have received the \$1200.00 certificate from Lowrance for last years' sponsorship. It needs to be used by October 31<sup>st</sup>.

The new scale that came to the TBF through Jim Canning has been used and is GREAT!! The sponsorship to fund the scale has not come in as fast as we expected. Jim Canning fronted the cash to purchase the scale and will be repaid as soon as the sponsorships come through. The scale came with a three year warrantee.

We still have oil and a few rejuvenade. We will purchase two more boxes of rejuvenade.

Dziob and Simons initially agreed to return half of the disputed lunker pool from the last open. They have since said that they will not honor this agreement. - 1. THIS IS A TEAM TOURNAMENT. Teams consist of two anglers in one boat.
- 2. All contestants, ages 16 or older, must be Connecticut licensed fishermen.
- 3. Live bait, trolling and ALCOHOLIC beverages are PROHIBITED. Artificial baits only.
- 4. Only one(1) rigged rod may be used at one time per contestant. Other rigged rods may be in the boat.
- 5. All bass must be caught live and in a conventional manner.
- 6. All fishing must be accomplished from the BOAT. Contestants cannot depart the BOAT to land a fish. All contestants must leave the official launch area by BOAT and return by BOAT.
- 7. Contestants who are NOT in the official launch area on time shall be DISQUALIFIED. An excuse given for tardiness will be considered by the Tournament Committee. If the excuse is voted acceptable, there will be no penalty.
- 8. Scoring will be determined by pounds to the one-hundredths. The tournament winners will be determined by total pounds and hundredths. Only LARGEMOUTH and SMALLMOUTH BASS will be weighed with an eight (8) fish limit.
- 9. ALL BASS will be a minimum of (12) twelve inches in length. Weighing in of short fish will result in a disqualification. One courtesy measure per team.
- 10. Ties will be broken in the following manner: 1) By weight of the largest fish. 2) By the total number of fish weighed.
- 11. Sportsmanship, courtesy, safety and conservation are expected from each participant. Each boat must have standard Coast Guard safety equipment.
- 12. Anglers have to wear their life jackets while the large motor is running.
- 12. Each boat must have a live well with working aerators; able to keep a full catch alive and well. The boat will also be equipped with a kill switch.
- 13. Boat numbers will be issued on receipt of paid entry. Boats will line up an idle in order to past the mouth of the Squantz Cove with out swamping the checkout boat!
- 14. The Tournament waters will be patrol by Tournament Judges, and they can be called upon to resolve any problems that might arise.
- 15. A quarter pound will be deducted for each dead fish and for each fish not released alive at the end of the Tournament. (If D.E.P. chooses to take a fish to study you will not be penalized).
- 16. At the weigh-in, each team will weigh in their fish together to obtain their placement in the standings. (One member can bring their bag of fish to the scales while the other keeps the boat safe.)

Weigh-in will be to the lake side of the launch. Once you check in with the check-in boat, stage to the lake side of the launch - make sure you stay far enough away from the launch so boaters can drive up on the trailers without hitting waiting boats.

17. The TBF of CT reserves the right to refuse any application.

#### PRESIDENT'S CORNER

I want to take just a minute here to thank Jim Canning for all of his efforts. I talked last month about the scale which Jim acquired for us, now he has brought us some local sponsors and is working to increase our membership. Thanks again Jim, your work for the Federation is greatly appreciated.

Now that I've dealt with the pleasant stuff,

I guess it's time to deal with the rest of what is going on in the organization. First off we need to address the attendance at our monthly meetings. We are having a really hard time getting enough people to the meetings to make a quorum. If we don't make a quorum, we cannot conduct business, and whether we like it or not there are always some issues that need to to be addressed. I hate to think that in the future the organization would have to impose penalties, just to force people to show up. Lets all start making an effort to have someone from the club show up, remember we're trying to be 100% user friendly and that means we really do need input from everyone.


